#### From the Assessor



# **Rising Property Taxes**

In 2023-2024, Michigan property owners faced the highest tax increases since Proposal A. The outlook for 2025 has improved over 2023-2024, which means a property owner can expect a "capped" increase in taxable value of 3.1% for 2025. If you purchased a home in 2024, your taxable value will increase and become your state Equalized Value (SEV), because the taxable value is uncapped. I will be glad to explain this further if you give me a call at 231 492-3844.
