F: PLANNING: Marijuana Ordinance from attorney with edits were approved and adopted and now will be sent back for final approval. We have not heard from County Planning as of yet.

- 1. **Payoff of the USDA Loan:** Our payoff is \$24328.23. We currently have \$3,400 in the debt fund and we will need to transfer \$21,000 from general to the debt fund to pay off. This will be done by a PAD on July 14th. This will complete the loan almost 15 yr ahead of schedule. **Motion by** Gary Porter, **seconded by** Abe Canfield to accept the transfer of funds to pay off the USDA loan. **Roll Call Vote** 5 Aye's 0 Nay's.
- 2. **New Shredder Machine:** Our current machine is no longer functioning. We need to purchase a new one. **Motion by** Abe Canfield, **seconded by** Gary Porter to accept the purchase up to \$500 a new shredder machine. **Roll Call Vote** 5 Aye's 0 Nay's.
