#### Planning Department Staff Update:

- Mr. Jarvi updated the commission on the Kaleva Village Council meeting that he recently attended. A public input session is scheduled for January 20<sup>th</sup>, before the village council meeting. This will hopefully help us with grant scoring.
- Mr. Jarvi gave an update on the Lifejacket Station Replenishment Grant Project. Mr. Jarvi is attending three upcoming municipality board/council meetings to update them and secure a letter of support. A letter of support has been already received from Bear Lake Village.
- Mr. Jarvi did some math and received a quote from a sporting goods company. 112 lifejackets could be bought for all the required sizes. Each station would get 35 new lifejackets in each size that is required.
