Benzie Manistee Dirtbirds Update: Mr. Knoper updated the members on the status of the newly created Benzie/Manistee Dirtbirds. Committee members have been hard at work proposing routes and working towards the creation of ORV trail maps. The community involvement has been inspiring and the local business and restaurants are eager to help.
