He gave out surveys for the board members to complete. The county wants to know who would be open to discussion on the topic. There are a few open community discussion sessions planned for the County master plan and this would be a part of those to start.

**Karla Kasten-**Manistee Recycling. She would like to know if we are interested in keeping with the county contract. She gave updates of the changes and more opportunities to come. Fees will stay the same currently and the new contracts will likely be out in July.

## **BOARD MEMBER REPORTS:**

A. TRUSTEES

Gary Porter: No Report

**Abe Canfield**: Abe turned in his affidavit to be on the ballot as trustee next term.

B. TREASURER: Lambda letter of breach in security was sent to Cogent to ask about the effect on us. Due to it being client information related and the township not having any information involved we should have nothing to worry about. We received the \$20,000 from Springdale for the Fire Contract. Food pantry will meet on the 16th of May at the hall. Feed America Food truck will be in Copemish on May 17th. Lisa from United Way is leaving. The Road Fund CD is up for renewal. We currently have \$6337 in it and if we add \$3662.41 to make \$10,000, we can renew for 7 months at 4.90% Motion by Gary Porter, seconded by Abe Canfield to approve the renewal of the Road CD. Roll Call Ayes 5 Nays 0. To date we have spent \$753,099.07 on the new hall project, with \$592,454.07 coming from USDA. The 1st principal/interest payment went through as of today. Next meeting we need to add the Bond resolution to the agenda for the L-429. C. CLERK: I attended the first clerk meeting since covid restrictions caused them to stop. We voted on officers and talked about the EV support contract through Election source. We need to decide on how we want support to be handled. Potentially it could be a up to a \$2400 cost per Federal Election year.

**D. SUPERVISOR**: Water and garbage have been opened at cemetery. Be aware of email phishing scams with Dave's name on them. Look closely at the email it is coming from.

**E. ZONING:** 2 permits. Still actively working on the Read rd. clean-up situation.

F: PLANNING: Cancelled May meeting.

*G: MRCM:* They are implementing lots of changes; a main priority is to update technology. ORV's can now drive on any county roads stating soon. Continued bridge repair in our area.
